I hope this email finds you both very well.

I have tried calling the Simon's Town Magistrate Court numerous times today but unfortunately the call goes unanswered.

This email serves to hereby notify you of the possible absence of a subpoenaed witness relevant to CAS 61/07/2022 [Case A738/22] opened by the SPCA.

There were two (2) subpoenas issued relevant to CAS 61/07/2022 to appear in court on Monday, 05/02/2024; one for Mr Jeffrey Mfini and another for Mr Jonathan Siviwe Noko.

Unfortunately, Mr Jonathan Siviwe Noko is no longer under the employ of the Cape of Good Hope SPCA and we have been unable to reach him to ensure he will get to Simon's Town Magistrate Court. Mr Jeffrey Mfini will still be attending court and complying with the relevant subpoena, however, we are not sure if Mr Noko will be able to make it due to being unable to reach him.

Please can we ask that this be explained to the magistrate accordingly if Mr Noko does not make it to Simon's Town Court. Please can the state bear this in mind on Monday, 05 February 2024.

We will follow up through Mr Mfini as well as yourselves next week Monday accordingly.
