He additionally called the respondent/ accused.</p> <p>The accused was arrested on 06 April 2023 and there were no further appearances in court.</p> <p>The accused is now retired, unemployed, and divorced.</p> <p>The accused is not fit to stand trial (ito Section 76 of CPA).</p> <p>Charges relating to obstruction and defeating the ends of justice must be brought against the accused and the matter must be placed on roll for diversion and community service.</p> <p>Parow SAPS OB Entry number (as per Werner's report): 535/04/2023.</p> <p>I tried to get the outstanding information myself by calling Parow SAPS CID (021 929 7100). The receptionist said she can't help me with the address, the accused's name, the A1's name, the charges, or the OB Entry Number. She kept saying she needs the CAS number (despite me explaining that WE need the CAS number) or the Detective's details.</p> <p>I tried getting through to a different line at the station (021 929 7000, 021 929 7005, 021 929 7037) but the calls went unanswered. I cannot assist the inspector any further. There is no copy docket on the drive. All I have access to is Werner's statement.</p> <p>Werner must obtain the following and upload it to WT before Shiven and I can action this case :</p> <ol style="list-style-type: none"><li>1. CAS number.</li><li>2. SAPS 14 A (Notice of Constitutional Rights – issued when accused arrested).</li><li>3. IO's details.</li></ol> |
