Thursday, 09 November 2023:

- Received by Jeff: Message from SAPS. CONST. T KHELEMBE will investigate your case LENTEGEUR ref nr CAS 163/11/2023.

Wednesday, 15 November 2023:

- Received by Jeff: Message from SAPS. ref nr CAS 163/11/2023 - Suspect was arrested and charged. First appearance in court will be on 2023/11/17.

Friday, 17 November 2023:

- 1st appearance in court. Message from SAPS. LENTEGEUR ref nr CAS 163/11/2023 - Court date postponed to 2023-12-08.

Friday, 08 December 2023:

- Jeff was subpoenaed to appear in court.
- the case has been postponed for an unknown date after the accused defense was not present at the court. The public prosecutor will again subpoena me to come to court.

Wednesday, 14 February 2024:

- Jeff subpoenaed to appear in court. Upon his attendance, the matter was postponed to Friday, 08 March 2024 for plea and trial.

Friday, 08 March 2024:

- Jeff attended court. The Prosecutor and the Legal Aid lawyer proposed mediation. Jeff denied the proposal and requested that the matter proceed. The matter was then further postponed to Wednesday, 08 May 2024 for plea and trial.

Wednesday, 08 May 2024:

- Jeff met with the Prosecutor. She told Jeff Legal Aid was off sick and so the matter was further postponed to Friday, 17 May 2024. She further confirmed with Jeff that she would subpoena him as well as the vet who examined the dog.

Friday, 17 May 2024:

- Jeff was never subpoenaed and the matter was postponed.

Tuesday, 21 May 2024:

Jeff went and met with the Clerk of the Court to find out the next court date and to confirm why the matter was postponed. The clerk informed Jeff that the matter was postponed to Wednesday, 12 June 2024 for Legal Aid consultation.

Tuesday, 11 June 2024:

The accused, Mr Alan Thorne (073 206 6530), went to Pound and enquired about his dog. He told Pound that he wanted feedback as the case was appearing in court the next day. Pound confirmed that the matter had to be discussed with Inspectorate but the accused insisted in getting called. He was not called.

Wednesday, 12 June 2024:

- Nicole attended court. Spoke to Prosecutor and she said the matter wasn't appearing as the dates were mixed up. She said she would contact me with a new date.

Thursday, 11 July 2024:

- The Senior Prosecutor, Mr Breyt, called Jeff and enquired about diversion. It was confirmed with the Mr Breyt that we do not agree to diversion and that the case must proceed. Case will appear in Court 3 on Tuesday, 30 July 2024.
