General Report Comments: Upon arrival Inspector Rowan Davids and myself met the owner who gave us access onto property as we shared received concerns. We observed the first two dogs who appeared to be under weight with body scores of 2/5. The owner told us he has a third dog aswell, but we did not see him. We then checked the shelter out which did not seem to be adequate as it was just a plank with afew bricks pakked on the side. The dogs had access to a clean living environment and adequate water.

We then asked owner about the third dog. Owner found him hiding in the furthest corner of the property. He appeared to be flat and we soon realized he was actually busy dying. We then convinced owner to surrender the dogs as he said he is not able to provide veterinary treatment. Admission numbers A48536; A48537 and A48538. No donation given.

A warning was issued: In future when any animals in your custody is sick; injured or compromised in any way it is your responsibility to ensure these animals are provided with adequate veterinary treatment without any delay.
