NOTICE IN TERMS OF THE CITY OF CAPE TOWN: ANIMAL KEEPING BY-LAW, PG 8527/2021 READ WITH GOVERNMENT NOTICE 1114, 2018

Following on the Impound Notice of your dogs on 23-06-2025 your attention is drawn to the following:

Your application has been successful. However, a re-occurrence involving your dogs may result in the summary disposal of the animals. You are authorised herewith to collect your animals subject to the following conditions:

1. The payment of all fees payable and due by you in respect of the impounded animals , **(R910.00 for impoundment fee: General ledger no. 811160 and P18040073).**
2. The identification and registration of the impounded animals and other animals linked to your property.
3.  Mandatory sterilisation of the unsterilized impounded dogs. This is to be done by an Animal Welfare Organization (SPCA) or by a competent veterinary practice identified by the authorised official. The cost associated with the sterilisation will be borne by you.
4. Your undertaking to abide by the terms identified in the compliance notice, which may be issued together with this communication, to ensure the necessary measures are in place to prevent a re-occurrence of the contravention and your compliance with the Animal Keeping By-law PG8527/2021.
5. That the dogs identified receive the appropriate behavioural training.
6. That the property identified above is adequately safeguarded so that your dogs does not have access to a public place or public street (Erection of gate, fence or runner), & signage displayed indicating the presence of dogs.
7. That the dogs is on a leash, humanely muzzled and under control when in a public place or public road.
8. The dogs may summarily be impounded if you do not adhere to conditions 2, 5, 6 and 7 above.

Please note that the docket will still be submitted to the prosecutor who may issue a Section 54 summons for you to appear in court in respect of the alleged contravention.

This Notice will be copied to the relevant organisation and will serve as notification for the release of the animals after the payment of the fees payable. The dogs must be collected within 7 days else they will be disposed of and you will still be liable for the fees payable.
