Thanks Rudolph but important distinction I need cleared please - the thing is has AACL confirmed that from date of my complaint onwards that the dog did indeed return to them? Yes the dog was allegedly at AACL the Wednesday-ish prior to my Tuesday complaint of last week (Jacqi posted to Facebook on that Wednesdayish). But on a technicality Jacqui and AACL may be saying "the dog has seen a vet" but date of any (possible) return vet trip needs to be cleared. Has the dog definitely been taken back to them with confirmed date of 30 Dec/31 Dec/1 Jan/2 Jan/3 Jan/4 Jan/5 Jan/6 Jan? Jacqi van der Veen bleated on her Facebook repeatedly that she could not get him into her car then did squat about it. What date does AACL say the dog last was at their vet (subsequent to around 23-25 Dec alleged vet visit)? The abdominal abscess burst and dropped (with Facebook video) specifically on Sunday 28 Dec 2025 and she kept finding excuses which is why Tues 30 Dec I reported to CoGH SPCA. But on Saturday 27 Dec 2025 Jacqi stated he is not well and needs to get to vet but went into how he's not loading and wants to bite (pain no doubt primary reason). So my complaint has been about whether the dog *returned* to AACL *after* my Tues 30 Dec complaint to SPCA?
