3. ENVIRONMENTAL CONDITIONS

4. FINDINGS & CONVERSATION

While driving into the area I was approached by Ms. Liza Arnold who stated she would like to surrender her cat due to noise complaints.

Ms. Arnold advised that the cat is on heat and making noise, and the neighbours are not happy with the noise that the cat is making.

We then proceeded to her property at 14E Thames Walk. Ms. Arnold also mentioned there was another dog she would like to surrender, however the dog does not belong to her. Upon arrival, the owner of the dog who resides next door came to fetch his dog and refused to surrender it.

I then took the cat in as an unwanted surrender.

Cat Details: Kitty, unsterilized male, White & Black, 10 years old. Condition: Fair.

At time of inspection water was provided, the living environment was clean, and the cat was roaming freely.

Owner advised of surrender process and sterilization options for future. Cat transported to SPCA.

5. ACTION TAKEN

Animal Surrendered to SPCA.

Dog issue resolved - owner collected dog and refused surrender. Owner counseled on benefits of sterilization.

6. INSPECTOR COMMENTS & FOLLOW-UP

Unwanted surrender of 1 cat completed due to noise/behavior while on heat. Dog matter closed as rightful owner collected dog and refused surrender. Conditions for cat were acceptable at time of collection.

Recommendation: Case to be closed. No further action required.
